INSTRUCTIONS TO FILE FOR DRIVING PRIVILEGES ON:

BMV Non-Compliance Suspension / BMV Out of State OVI Suspension BMV 12 Point Suspension / BMV Reinstatement Fee Payment Plan

To file a motion, financial responsibility insurance (SR-22 or Bond) must be current and filed with the BMV *if required*. You must have all other suspensions in compliance. The Non-Compliance 2nd offense has a 1-year suspension with a 15-day mandatory suspension *without* privileges. The Non-Compliance 3rd and subsequent offenses have a 2-year suspension and a 30-day mandatory suspension *without* privileges.

THE FILING FEE IS \$116.00

1. **Hamilton County residents** start by calling the Hamilton County License Intervention Program 8:00am-3:30PM (513) 946-5153 to get Pre-screened. Your BMV record will be checked to determine if you are eligible to file, if so a Pre-Screen report form will be sent to you by e-mail.
2. The Pre-Screen report can be e-filed on the courtclerk.org website or you can take it to room 115 in the Court House to file your motion, pay the filing fee and get your court date.
3. **On the day of court, you must present** your automobile insurance, proof of employment, school schedules and any other documents for which you are applying for privileges.

If you fail to show these documents, you will be denied.

4. If granted, you **must** take the Court Order driving privileges to the BMV to be recorded on your record **BEFORE** you may drive. At that time the BMV will issue you a letter to renew or test if needed.

The letters to drive that have a payment plan are only valid as long as the monthly payments are made & financial responsibility is maintained. If you stop paying, the letter is void and you may not drive.
